What is the Employee Giving Campaign?

The Employee Giving Campaign allows every member of the Harris Health System family to support, through their personal financial contribution, a specific Harris Health Pavilion's designated project or other Harris Health System projects.

When is the Employee Giving Campaign?

The employee giving campaign will run from Monday, May 20 through Friday, June 14, 2019.

Why should I donate?

This campaign is specifically designed for each employee to support a specific Pavilion project that will benefit all patients and employees within that Pavilion. All employees will see the tangible benefits of their donation.

What is the goal?

This is an opportunity for every employee to make a gift in support of our Pavilion's projects. We hope to have each and every employee make a gift – no matter the amount.

How do I make a donation?

You can make a recurring or a one-time donation via payroll deduction through PeopleSoft, a one-time gift with a check made payable to the HCHD Foundation and sent interoffice to the HCHD Foundation, a credit card payment via the donation form, completed and sent interoffice to the HCHD Foundation, or cash donations can be made directly to the HCHD Foundation's office. How much should I contribute and is my contribution tax deductible?
